JUSTIFICATION FOR REAL WORLD TESTING APPROACH

This is a Real World Testing Plan for below the certification criteria:

§170.315(b)(10) - Electronic Health Information export.

Certified Health IT is utilized by providers in Psychiatry settings. Certification criteria involving the data export capabilities as defined in the Electronic Health Record (EHR) certification requirements will be tested in this plan. All certification criteria listed in this plan are not part of standard workflows in these settings, yet the Certified Health IT Module is capable of exporting patient health information in a structured and standardized format, including C-CDA and JSON, ensuring full compliance with the certification requirements. The approach chosen will identify the frequency of data export requests made and completed during the interval, monitoring patient data portability and accessibility. The goal of this approach is to demonstrate that both the data portability and conformance capabilities of the Certified Health IT module meet the requirements of the specified certification criterion.

The goal is to support patient transitions, data portability, and regulatory compliance, allowing patients or authorized parties to have access to their complete health information in a standardized, interoperable format.

The B10 measure validates the system's capability to export EHI while adhering to the technical standards for interoperability and data privacy. By evaluating the frequency and accuracy of data exports, this measure ensures compliance with certification criteria and supports the seamless exchange of health information.

Export functionality	 The Real World Testing approach will ensure that certified health IT modules comply with the required technical standards and certification criteria for electronic health information (EHI) export, allowing providers and patients to easily retrieve and export their health data. Providers and patients (or their authorized representatives) will be able to export EHI in structured formats that meet certification requirements, ensuring data portability and interoperability with other systems or platforms. Error rates during the EHI export process will be monitored, tracked, and trended over time to identify issues, drive improvements, and ensure ongoing compliance with certification standards.
